#### Road Safety Act 1986

SECTION 99B(4) NOTICE

Declaration Under Section 99B(4) in Relation to Non-Road Activities on the Roads Specified in Column 1 of Table 2 for the 2013 Ironman Asia-Pacific Championship on Sunday 24 March 2013

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the 2013 Ironman Asia-Pacific Championship triathlon from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the roads specified in column 1 of Table 2 on Sunday 24 March 2013.

# 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a nonroad activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect from 3.00 am Sunday 24 March 2013.

## 4 Expiry

This notice expires at 1.00 am Monday 25 March 2013.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) 'Event' means the 2013 Ironman Asia-Pacific Championship triathlon, to be held on Sunday 24 and Monday 25 March 2013, and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of USM Events, whose presence is reasonably required to ensure the safe conduct of the Event.

## 6 Declaration

I, Bruce Gidley, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2.

## Road Management Act 2004

#### SCHEDULE 4 CLAUSE 5

Designation of Tow Away Area

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister (referred to in this instrument as a 'tow-away area'), and may charge the owner of the vehicle a reasonable fee.

For the purposes of that provision, I, Bruce Gidley, Acting Chief Executive of the Roads Corporation and delegate of the Minister for Roads, designate the locations specified and shown on the attached plan, to be a tow-away area.

This instrument takes effect at 3.00 am Sunday 24 March 2013 and expires at 11.00 pm Sunday 24 March 2013.


