CONDITIONS UNDER SECTION 220D

I, Jim Betts, Secretary to the Department of Transport, pursuant to section 220D of the **Transport (Compliance and Miscellaneous) Act 1983**, hereby determine and publish in the Government Gazette the following conditions (the 2013 Miscellaneous Amending Conditions – General) which amend the conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** contained in the Victorian Fares and Ticketing Manual (General) (effective 1 January 2013) published in the Victoria Government Gazette No. S 451 dated Friday 21 December 2012.

The 2013 Miscellaneous Amending Conditions – General take effect from and including 22 March 2013.

2013 MISCELLANEOUS AMENDING CONDITIONS – GENERAL

The conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** contained in the Victorian Fares and Ticketing Manual (General) (effective 1 January 2013) published in the Victoria Government Gazette No. S 451 dated Friday 21 December 2012 (the General Manual) are amended as follows.

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the General Manual and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.

In Chapter 1 of the General Manual, for the heading '**Role of the Secretary of the Department of Transport and Public Transport Victoria**' substitute '**Role of the Secretary to the Department of Transport and Public Transport Victoria**'.

Note: In Chapter 1 of the General Manual, in the paragraph in green text under the heading '**Role of the Secretary to the Department of Transport and Public Transport Victoria**', '**Secretary of the Department of Transport**' should read '**Secretary to the Department of Transport**'.

In Chapter 2 of the General Manual, in the table under the heading '**V/Line Fare Table 2013**', in the row commencing 'B' –

- (a) in the column under the headings 'OFF-PEAK DAILY' and 'FULL', for 'n/a' substitute '11.70'; and
- (b) in the column under the headings 'OFF-PEAK DAILY' and 'CONC', for 'n/a' substitute '5.90'.

In Chapter 2 of the General Manual, in the table under the heading '**Melbourne to' charging units and fare codes**', in the row commencing 'Lorne', in the column under the heading '**Charging units**', for '171' substitute '170'.

In Chapter 4 of the General Manual, under the heading '**Regional buses**', in the table under the heading '**Regional City & Town Service Fares – Category B**', after the row commencing 'Concession 2 hour' insert the following two rows –

'Full fare Daily	\$3.40
------------------	--------

Concession Daily	\$2.20
------------------	--------

In Chapter 8 of the General Manual, under the heading '**Metcard**', after the third paragraph under the heading '**Replacement at Premium Stations**' insert –

'If the number of cents in the value to be loaded onto an existing or purchased myki ends in 1c or 2c, it is rounded down to the nearest 10c. If it ends in 3c or 4c, it is rounded up to the nearest 5c. If it ends in 6c or 7c, it is rounded down to the nearest 5c. If it ends in 8c or 9c, it is rounded up to the nearest 10c.'

Note: In Chapter 10 of the General Manual, under the heading '**Objections to infringement notices**', the fax number '**9665 9400**' is incorrect and should read '**9655 8855**'.
