### Livestock Disease Control Act 1994

# ORDER DECLARING A CONTROL AREA FOR ABALONE VIRAL GANGLIONEURITIS

- I, Peter Walsh, Minister for Agriculture and Food Security, under section 29 of the **Livestock Disease Control Act 1994** –
- (a) revoke the Order declaring a Control Area with respect to Abalone Viral Ganglioneuritis made on 9 March 2012 and published in the Government Gazette No. S87 on 19 March 2012; and
- (b) declare the area described in Schedule 1 to be a Control Area in respect of the exotic disease Abalone Viral Ganglioneuritis; and
- (c) specify the requirements in Schedule 2 as those which are to operate in the Control Area; and
- (d) identify abalone as the class of livestock that are affected by this Order.

This Order has effect for 12 months from the day it is published in the Government Gazette. In this Order:

- 'abalone' means blacklip and greenlip abalone and includes all other species, forms, races and hybrids of abalone;
- **'untreated effluent'** means any sea water used in the course of holding abalone that has not been treated in the manner and to the standard determined by the Chief Veterinary Officer of Victoria.

### Schedule 1

The premises of Pacific Shoji Pty Ltd located on the land at 295 Dandos Road, Lara, Victoria.

#### Schedule 2

The following activity in the Control Area is prohibited, unless the activity is in accordance with a permit issued by an Inspector –

• The discharge of untreated effluent from the facility at this site where abalone are held. Dated 22 March 2013
