Notice of Approval of Amendment
Amendment VC89

The Minister for Planning has approved Amendment VC89 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by:

- Removing Clause 52.43 – Interim measures for bushfire protection.
- Amending the schedule to Clause 53.01 – Upper Yarra Valley and Dandenong Ranges Region Provisions in the Yarra Ranges Planning Scheme to:
 - a. Exempt buildings and works to which Clause 52.48 – Bushfire protection: exemptions, applies from the requirements of Clause 1 of the schedule.
 - b. Introduce an exemption at Clause 4 of the schedule to enable the removal, destruction or lopping of any vegetation to reduce fuel loads on roadsides without a planning permit, provided it is undertaken in accordance with the written agreement of the Secretary to the Department of Sustainability and Environment.

The Minister for Planning has approved Amendment VC97 to the Victoria Planning Provisions (VPP) and all planning schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes the Victoria Planning Provisions and all planning schemes in Victoria by:

- Amending Clause 52.38 (2009 Bushfire recovery) to extend the timeframe for continued use of a building for temporary accommodation without a planning permit to 30 April 2014.
- Amending Clause 52.39 (2009 Bushfire – Replacement buildings) to extend the timeframe for submitting a site plan to the responsible authority for rebuilding a dwelling, dependent person's unit or building used for agriculture to 30 April 2014.
