
#### INDIGO SHIRE COUNCIL


Proposed Closure to a Section of Warracknabeal Lane 24

#### PROPOSAL TO MAKE NEW LOCAL LAWS

Notice is hereby given that the Colac Otway Shire Council proposes to make three Local Laws. These are:

Local Law No 1 – Consumption of Alcohol in Public Places Local Law 2013

Local Law No 2 - General Local Law 2013

Local Law No 3 - Livestock Local Law 2013

The purposes and general purport of the Local Laws are to:

#### **Local Law No 1 – Consumption of Liquor in Public Places Local Law 2013:**

- revoke Local Law No 1 of 2005 Consumption of Liquor in Public Places.
- regulate and control the consumption of liquor and possession of liquor other than in a sealed container;
  - on a road:
  - in or at a public place;
  - in or on a stationery vehicle;
  - on vacant private land; and
- prevent behaviour which
  - constitutes or may constitute a nuisance;
  - may be detrimental to health or safety;
  - affects the enjoyment of public and other places.

The key changes proposed to the current Local Law 1 are to change the use of the term liquor to alcohol throughout the document to ensure one term is consistently used and to increase the penalty amount for consuming alcohol in a public place from \$100 to \$200.

#### Local Law No 2 - General Local Law 2013

- revoke Local Law No 2 of 2005 General Local Law.
- provide for the peace, order and good government of the municipality;

- minimise the spread of livestock disease and noxious weeds in the municipal district;
- provide for the welfare of livestock when being grazed or moved;
- alert other road users to the presence on roads of livestock in the municipal district in the interests of safe use of roads:
- regulate the adequacy of fencing of livestock;
- put in place mechanisms for rectifying inadequate fencing;
- fix fees or charges relating to the impounding of livestock and all other costs incidental thereto;
- fix charges for road use by livestock within the municipal district;
- enter arrangements with neighbouring councils relating to impounding, collecting trespassing livestock, housing and releasing those livestock;
- prescribe penalties for contravention of any provisions of this local law; and
- provide generally for the peace, order and good government of the municipal district including in particular, the administration of Council's powers and functions.

The key change to the current Local Law 3 is the removal of the requirement to obtain a stock crossing permit. Although under the proposed Local Law permits would not be required, stock crossings must still be managed in accordance with VicRoads signage guidelines and in a manner that does not damage the road surface.

#### **EXEMPTION**

#### Application No. A57/2013

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Wet on Wellington (the applicant). The application for exemption is to enable the applicant to limit patronage at its establishment to males aged 30 and under at one function per month and to advertise that fact (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Shane Charles Lardner, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant has been operating primarily as a gay and bisexual men's sauna since 2001. It was first granted an exemption to, once each month, operate a function for under 30s in 2006. It was granted a further exemption in the same terms in 2009.
- The purpose of the monthly function is provide younger gay and bisexual males with a safe alternative meeting place other than the usual hotel or nightclub, which can be daunting. The monthly functions have operated since 2006 without any complaint from anyone aged over 30 years.
- The application is supported by the Victoria Aids Council, which provides volunteers to attend the night and engage with patrons concerning important issues related to HIV prevention and general sexual health. The feedback about the night received by those volunteers is said to be overwhelmingly positive. The application is also supported by the South Eastern Centre Against Sexual Assault whose staff provide training to the applicant's managers and staff concerning sexual assault, issues of consent and the availability of support services.
- The exemption granted in 2009 expires on 22 April 2013. No exception applies to the exempt conduct. After 22 April 2013, in the absence of a further exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of women aged between 18 and 30 years and men and women aged over 30 years who would wish to attend on

the monthly function night. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from 23 April 2013 to 22 April 2018.

- I, Edward Smith, Manager Water Supply West, Southern Rural Water (the Waterway Manager for Pykes Creek Reservoir), declare under section 203(3) of the **Marine Safety Act 2010** that the Melbourne Runabout and Speedboat Club Griffith Cup racing event on 26, 27 and 28 April 2013 is exempt from:
- 1. the requirements to operate a vessel at a speed not exceeding 5 knots within 50 metres of another vessel and fixed or floating structures, as detailed in Clauses 2(c) and 3(b) of the Notice under section 15(2) of the **Marine Act 1988** (Vic.);

#### OCCUPATIONAL HEALTH AND SAFETY REGULATIONS 2007

#### Notice of Exemption

In accordance with regulation 7.2.4 of the Occupational Health and Safety Regulations 2007 (the Regulations) the Victorian WorkCover Authority (WorkSafe Victoria) grants the following exemption under regulation 7.2.1 of the Regulations after being satisfied that the granting of the exemption will result in a level of health and safety that is at least equivalent to that which would be achieved by observance of the provision the subject of the exemption or that the provision that is to be the subject of the exemption is an administrative requirement under the Regulations – (i) that is not directly associated with a risk control measure; and (ii) that are inappropriate or unnecessary in the circumstances:

Persons are exempted from compliance with the provisions of Subdivision 2 of Division 7 of Part 3.5 (Plant) of the Occupational Health and Safety Regulations 2007 requiring the registration in accordance with Part 6.2 (Registration) of a go kart as an item of plant under Part 2 of Schedule 2 being an amusement structure to which AS 3533.1 – Amusement rides and devices – Part 1; Design and construction applies.

This exemption is subject to the following conditions in accordance with regulation 7.2.8 of the Occupational Health and Safety Regulations 2007:

- (i) An employer or self-employed person must ensure that any record of inspections and maintenance carried out on a go kart is retained for the period that the employer or selfemployed person has management or control of the go kart;
- (ii) An employer or self-employed person must notify WorkSafe Victoria immediately after becoming aware that an incident has occurred at a workplace under the management or control of the employer or self-employed person that exposes a person in the immediate vicinity to an immediate risk to the person's health or safety through the collapse, overturning, failure or malfunction of, or damage to a go kart (the incident) unless the employer or self-employed person is the only person injured or otherwise harmed, or exposed to the risk, by the incident:
- (iii) Within 48 hours after being required to notify WorkSafe Victoria of the incident, the employer or self-employed person must also give WorkSafe Victoria a written record of the incident;
- (iv) The employer or self-employed person must keep a copy of the record of the incident for at least 5 years and make a copy of the record available for inspection by
  - (a) a WorkSafe Victoria inspector; or
  - (b) a person, or a representative of a person, injured in the incident or whose health or safety was exposed to immediate risk by the incident;
  - (c) a representative of a person whose death was caused by the incident; or
  - (d) in the case only of an employer
    - (i) if any of the employees of the employer are members of a designated work group, a health and safety representative for the designated work group; or
    - (ii) the members of each health and safety committee (if any) established by the employer.
- (v) An employer or self-employed person required to notify WorkSafe Victoria of the incident that has occurred at a workplace must ensure that the site where it occurred is not disturbed until a WorkSafe Victoria inspector arrives at the site or such other time as an inspector directs, except that a site may be disturbed for the purpose of
  - (a) protecting the health or safety of a person; or
  - (b) aiding an injured person involved in the incident; or

(c) taking essential action to make the site safe or to prevent a further occurrence of the incident.

This exemption starts on and from the date this notice is published in the Government Gazette.

## ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION OF CITRUS TRISTEZA VIRUS HOST MATERIAL INTO VICTORIA

I, Pat Sharkey, as delegate of the Minister for Agriculture, make the following Order: Dated 11 April 2013

#### 1 Objective

The objective of this Order is to prevent the entry or importation of the exotic disease Citrus Tristeza Virus into Victoria.

#### 2 Authorising provision

This Order is made under section 36 of the **Plant Biosecurity Act 2010** ('the Act').

#### 3 Revocation

The Order made under section 24 the **Plant Health and Plant Products Act 1995** on 24 April 2012 and published in Government Gazette G18 on 3 May 2012 is revoked.

#### 4 Definitions

In this Order -

'citrus tristeza virus' means the stem pitting strain of the exotic disease citrus tristeza virus; 'citrus tristeza virus host material' means any plant or plant part of the genus *Citrus* and the genus *Fortunella*, excluding fruit or kaffir lime leaves for domestic consumption.

#### 5 Controls applying to citrus tristeza virus host material

- (1) The entry or importation into Victoria of any citrus tristeza virus host material is prohibited.
- (2) Sub-clause (1) does not apply if the citrus tristeza virus host material was grown, sourced or last used on a property that is located in a State or Territory or part of a State or Territory for which an area freedom certificate, issued by an officer responsible for agriculture in the State or Territory where the citrus tristeza virus host material was grown, sourced or last used, is currently in force certifying that the State or Territory or part of the State or Territory is known to be free of citrus tristeza virus.

Note: Section 38 of the **Plant Biosecurity Act 2010** provides that a person is guilty of an offence and a penalty not exceeding 60 penalty units for a natural person, or 300 penalty units for a body corporate, for knowingly breaching an importation order.




