## **Road Safety Act 1986**

### **SAFE DRIVING PROGRAM – THE COST RECOVERY FEE FOR PARTICIPANTS IN THE PROGRAM**

Under section 84BV(1) of the **Road Safety Act 1986**, VicRoads has determined that participants in the Safe Driving Program, which is established under Part 6AB of the **Road Safety Act 1986**, must pay a fee of \$527.

This amount, which will be reviewed annually by VicRoads, will apply for the first five years of the Program, after which time a new fee will be established by VicRoads. The cost recovery fee is intended to ensure that the Government fully recovers the costs associated with establishing and administering the Safe Driving Program.

The fee will be reviewed annually by VicRoads and adjusted, if necessary, to ensure that over-recovery does not occur.

The cost recovery fee is in addition to a commercial fee which participants in an approved Safe Driving Program will need to pay to approved Program providers. This commercial fee will be set by the approved provider.
