Marine Safety Act 2010

REGULATION OF NAVIGATION AROUND WORKS

Parks Victoria, as the declared waterway manager for the waters of the Yarra River upstream of the port water of the Port of Melbourne under the **Marine Safety Act 2010** (Act), makes the following notice under the section 211(1)(b)(i) of the Act.

For the purposes of the work activity proposed by the Golder Associates Pty Ltd for the geotechnical investigation works on the Yarra River for the Melbourne Metro Project, on behalf of Public Transport Victoria, in their application of the 4 March 2013, under the section 211(1)(b)(i), Parks Victoria provides the following notice that:

1. Prohibits the navigation and other movement of vessels in the works areas, excluding Parks Victoria vessels and other vessels involved in the works,
2. Specifies the work areas and duration as:
 - a. an area that extends from the downstream drip line of the Princes Bridge southern arch for a distance of 60 m upstream, covering the width of the southern arch and includes the closure of the Princes Bridge southern arch. The works area will be delineated by water communication buoys. The works duration applies from 7 am 19 May 2013 to 7 pm 2 June 2013.
 - b. an area that extends from the downstream drip line of the Princes Bridge central arch for a distance of 45 m upstream, covering the width of the central arch and includes the closure of the Princes Bridge central arch. The works duration applies from 7 am 3 June 2013 to 7 pm 16 June 2013.
 - c. an area that extends from the downstream drip line of Princes Bridge northern arch for a distance of 35 m upstream, covering the width of the northern arch and includes the closure of the Princes Bridge northern arch. The works duration applies from 7 am 17 June 2013 to 7 pm 30 June 2013.
