ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes or declares the roads described in the Schedule and on the plans attached. The effects of these revocations and declarations on road names are described in Table 1.

SCHEDULE

ARTERIAL ROAD

- a) Those parts of Malmsbury–Elphinstone Road identified by hatching on the plan numbered GP22783 are revoked as described in the legend in the said plan.
- b) Those parts of Elphinstone Road identified by hatching on the plan numbered GP22784 are revoked as described in the legend in the said plan.
- c) That part of Elphinstone–Harcourt North Road identified by heavy broken line on the plan numbered GP277AR is revoked as described in the legend in the said plan.
- d) Those parts of Midland Highway identified by hatching on the plan numbered GP278AR are revoked as described in the legend in the said plan.

MUNICIPAL ROAD

- e) Those parts of Diggers Way identified by hatching on the plans numbered GP22783A and GP22784A are declared as described in the legend in the said plans.
- f) That part of Harmony Way identified by heavy line on the plan numbered GP42MU is declared as described in the legend in the said plan.
- g) Those parts of Victoria Road identified by hatching on the plan numbered GP43MU are declared as described in the legend in the said plan.
- h) That part of Mennens Lane identified by hatching on the plan numbered GP52MU is declared as described in the legend in the said plan.
- i) That part of Old School Lane identified by hatching on the plan numbered GP52MU is declared as described in the legend in the said plan.
