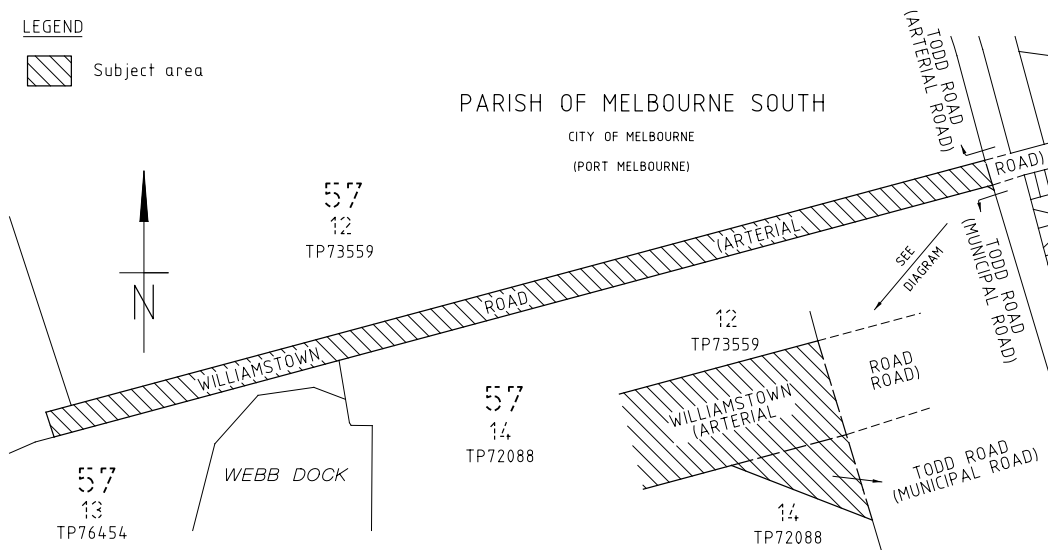

EXEMPTION FROM GIVING NOTICE OF THE PROPOSED DISCONTINUANCE OF PART OF WILLIAMSTOWN ROAD AND PART OF TODD ROAD FOR PORT CAPACITY PROJECT PURPOSES

I, Terry Mulder, Minister for Roads, under sub-section 12(11)(b) of the **Road Management Act 2004** exempt VicRoads from the requirements of sub-sections 12(4) to 12(10) of that Act for the proposed road discontinuance of the part of Williamstown Road and the part of Todd Road in Port Melbourne, at the location shown generally in the diagram below and more particularly as Parcels 1 and 2 on VicRoads Survey Plan SP22870 and Parcel 21 on VicRoads Survey Plan SP22871, copies of which may be requested from VicRoads. These road discontinuances are required for the purposes of the Port Capacity Project.

ROAD DECLARATION AND DISCONTINUATIONS

ROAD DECLARATIONS

VicRoads, pursuant to section 14 of the **Road Management Act 2004**, upon publication of this notice revokes the road described in Schedule A and on the plan attached. The effect of this revocation on road names is described in Table 1.

ROAD DISCONTINUATIONS

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the roads described in Schedule B and on the plans attached subject to the right, power and interest held by CitiPower Pty and South East Water Corporation over land parcels E-1, E-2 and E-3 described on the plans as provided for in section 207C of the **Local Government Act 1989**. VicRoads does not intend to exercise any power pursuant to clause 15(1) of Schedule 5 of the **Road Management Act 2004** in relation to selling the discontinued area.

SCHEDULE A**ARTERIAL ROAD**

SCHEDULE B**ARTERIAL ROAD**

- b) That part of Williamstown Road identified by hatching on the plan numbered GP22870 is discontinued as described in the legend in the said plan.

- c) That part of Todd Road identified by hatching on the plan numbered GP22870A is discontinued as described in the legend in the said plan.

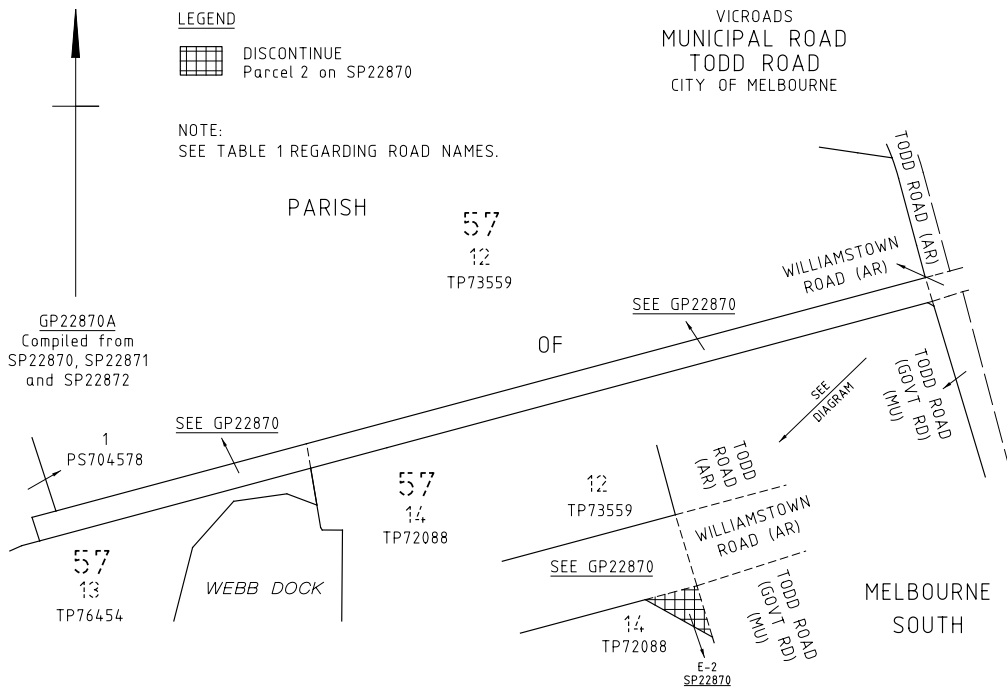
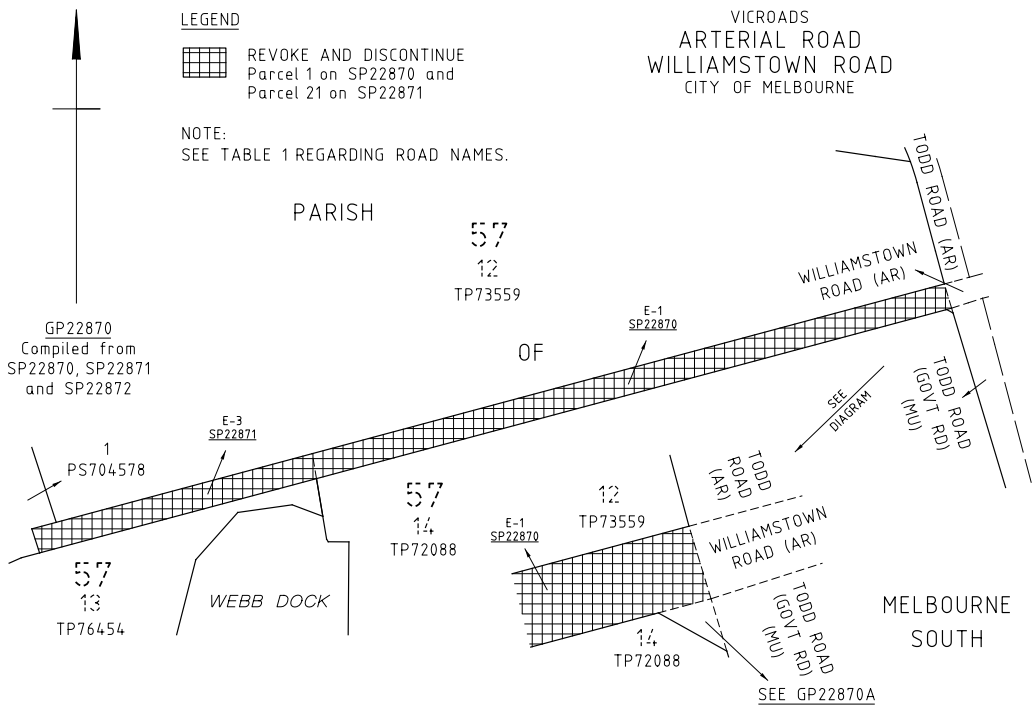
