ORDER APPOINTING PERSONS OR BODIES TO BE WATERWAY MANAGERS IN RESPECT OF SPECIFIED STATE WATERS

I, David Hodgett, Minister for Ports make the following Order.

Pursuant to section 6(1)(b) of the **Marine Safety Act 2010** the order made under section 3(3)(b) of the **Marine Act 1988** and published in the Government Gazette (S220) on 28 June 2012 is amended to declare the persons or bodies listed in Part 1, Municipal Councils, Column 1 of Table 1 to be a waterway manager in respect of the State waters specified opposite the name of the waterway manager in Column 2 of Table 1.

Pursuant to section 6(3) of the **Marine Safety Act 2010**, Glenelg Shire Council shall be the appointed waterway manager in respect of the waters of the local port of Portland Bay as detailed in Plan LEGL./13-009 till 27 June 2017.

URGENT SAFETY RULE

I, Peter Corcoran, the Director Maritime Safety (as delegate of the Director, Transport Safety), under section 186(2) of the **Marine Safety Act 2010** make the following Urgent Safety Rule.

From the time of publication of this Notice until 20 October 2013 the rules regulating the operation of vessels on the waters of the Winton Wetlands set out in Schedule 86 of the Notice under section 15(2) of the **Marine Act 1988** are amended to read:

SCHEDULE 87 WATERS – WINTON WETLANDS

Waterway Manager – Winton Wetlands Committee of Management Inc.

1. Five (5) knot speed restriction for the purposes of Clause 7. The whole of the waters of the Winton Wetlands are subject to a speed restriction of 5 knots.

SPECIAL

2. Prohibition on Vessels with Engines for the purposes of Clause 10.

The whole of the waters of Winton Wetlands are prohibited to vessels with engines used for propulsion (excluding those vessels authorised by the Winton Wetlands Committee of Management Inc.)
