- 40/2013 (1) This Act comes into operation on the day on which it receives the Royal Assent.
- 41/2013 (1) This Act (except Part 2, sections 13 and 27 and Parts 5 and 7) comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Section 27 is taken to have come into operation on 1 July 2012.
- (3) Section 13 is taken to have come into operation on 8 May 2013.
- (4) Parts 5 and 7 come into operation on 1 July 2013.
- (5) Part 2 comes into operation on 1 January 2014.
- 42/2013 (1) Subject to subsection (2), this Act (other than Division 2 of Part 2) comes into operation on a day or days to be proclaimed.
- (2) If a provision referred to in subsection (1) does not come into operation before 1 January 2014, it comes into operation on that day.
- (3) Subject to subsection (4), Division 2 of Part 2 comes into operation on a day or days to be proclaimed.
- (4) If a provision referred to in subsection (3) does not come into operation before 1 January 2015, it comes into operation on that day.
- 43/2013 (1) This Part and Division 2 of Part 5 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Divisions 1, 3 and 4 of Part 5 come into operation on 1 July 2013.
- (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (4) If a provision referred to in subsection (3) does not come into operation before 30 June 2014, it comes into operation on that day.
