ROAD DECLARATIONS AND DISCONTINUATION

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes and declares the roads described in Schedule A and on the plans attached. VicRoads also authorises and withdraws the access points described in Schedule C and on the plan attached. The affects of these revocations and declarations on road names are described in Table 1.

ROAD DISCONTINUATION

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the road described in Schedule B and on the plan attached and approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads under section 31 of the latter said Act.

SCHEDULE A

FREEWAY

- a) That part of Princes Freeway identified by hatching on the plan numbered GP21275 is revoked as described in the legend in the said plan.

ARTERIAL ROAD

- b) Those parts of Kings Road identified by hatching on the plans numbered GP21971A and GP21972A are declared as described in the legend in the said plans.
- c) Those parts of Carrum Downs – Seaford Road identified by hatching on the plan numbered GP22118 are declared as described in the legend in the said plan.
- d) Those parts of Cranbourne – Narre Warren Road identified by hatching on the plans numbered GP22860 and GP22873 are declared as described in the legend in the said plans.

SCHEDULE B

- e) That part of Princes Freeway identified by hatching on the plan numbered GP21275 is discontinued as described in the legend in the said plan.
