PROCLAMATION

I, Alex Chernov, Governor of Victoria, declare that I have today assented in Her Majesty's name to the following Bills:

- 30/2013 Heavy Vehicle National Law Application Act 2013
- 31/2013 Justice Legislation Amendment Act 2013
- 32/2013 Sentencing Amendment (Abolition of Suspended Sentences and Other Matters) Act 2013

(L.S.) ALEX CHERNOV Governor By His Excellency's Command DENIS NAPTHINE MP Premier of Victoria 30/2013 (1)This Act comes into operation on a day or days to be proclaimed. This Part and Part 6 come into operation on the day on which this Act receives 31/2013 (1)the Royal Assent. Parts 4, 5 and 8 come into operation on the day after the day on which this Act (2)receives the Royal Assent. (3) Part 3 is taken to have come into operation on 17 April 2013. Subject to subsection (5), the remaining provisions of this Act come into (4) operation on a day or days to be proclaimed. (5) If a provision referred to in subsection (4) does not come into operation before 30 April 2014, it comes into operation on that day. This Part, Division 1 of Part 2 and sections 33, 34, 35, 36, 38, 39, 40, 41, 42, 32/2013 (1)43, 44, 45 and 52 come into operation on the day after the day on which this Act receives the Royal Assent. Subject to subsection (3), Division 2 of Part 2 comes into operation on a day to (2)be proclaimed. If Division 2 of Part 2 does not come into operation before 1 December 2013, it (3) comes into operation on that day. Subject to subsection (5), the remaining provisions of this Act come into (4) operation on a day or days to be proclaimed.

(5) If a provision referred to in subsection (4) does not come into operation before 1 September 2014, it comes into operation on that day.
