- 30/2013 (1) This Act comes into operation on a day or days to be proclaimed.
- 31/2013 (1) This Part and Part 6 come into operation on the day on which this Act receives the Royal Assent.
- (2) Parts 4, 5 and 8 come into operation on the day after the day on which this Act receives the Royal Assent.
- (3) Part 3 is taken to have come into operation on 17 April 2013.
- (4) Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (5) If a provision referred to in subsection (4) does not come into operation before 30 April 2014, it comes into operation on that day.
- 32/2013 (1) This Part, Division 1 of Part 2 and sections 33, 34, 35, 36, 38, 39, 40, 41, 42, 43, 44, 45 and 52 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), Division 2 of Part 2 comes into operation on a day to be proclaimed.
- (3) If Division 2 of Part 2 does not come into operation before 1 December 2013, it comes into operation on that day.
- (4) Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (5) If a provision referred to in subsection (4) does not come into operation before 1 September 2014, it comes into operation on that day.
