## Road Safety Act 1986

### SECTION 99B(4) NOTICE

Declaration Under Section 99B(4) in Relation to Non-Road Activities on  
Plumpton Road, Diggers Rest, Between Holden Road and Melton Highway for the  
Television Commercial Filming Event on Tuesday 16 July 2013

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the Television Commercial Filming from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on Plumpton Road, between Melton Highway and Holden Road on Tuesday 16 July 2013.

#### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect on Tuesday 16 July 2013 9.30 am.

#### 4 Expiry

This notice expires on Tuesday 16 July 2013 11.00 am.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) ‘Event’ means the Television Commercial Filming Event, to be held on Tuesday 16 July 2013 on Plumpton Road, Diggers Rest between Holden Road and Melton Highway; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of Annix, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Gary Liddle, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2.
