



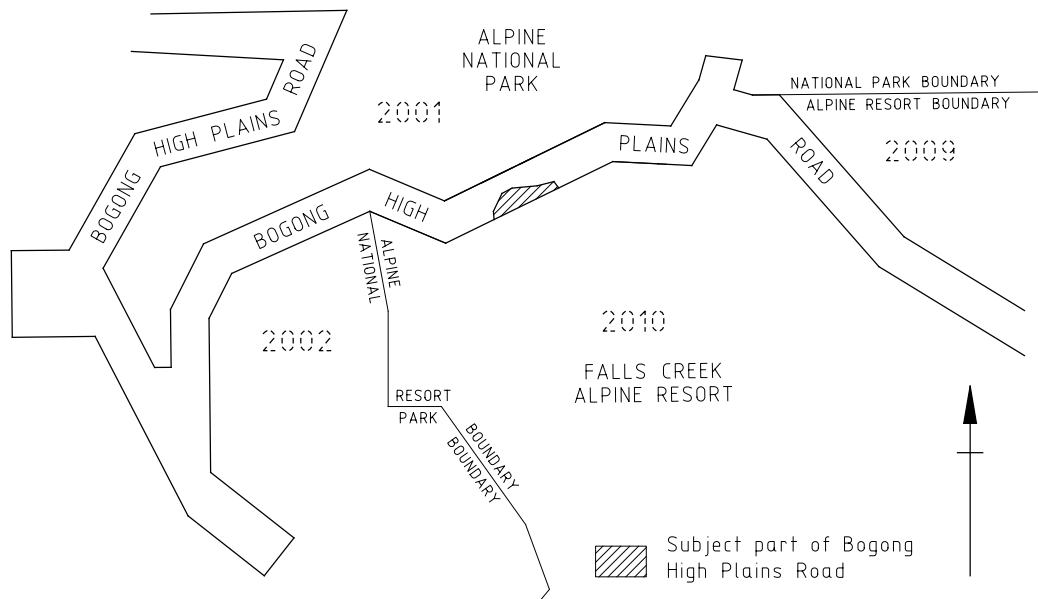

Road Management Act 2004

EXEMPTION FROM GIVING NOTICE OF THE PROPOSED DISCONTINUANCE OF PART OF BOGONG HIGH PLAINS ROAD FOR **ALPINE RESORTS AND NATIONAL PARKS ACTS AMENDMENT ACT 2013** PURPOSES

I, Terry Mulder, Minister for Roads, under sub-section 12(11)(b) of the **Road Management Act 2004** exempt VicRoads from the requirements of sub-sections 12(4) to 12(10) of that Act for the proposed road discontinuance of the part of Bogong High Plains Road at Howman's Gap, at the location shown generally in the diagram below and more particularly as parcel 1 on VicRoads Survey Plan SP22838; a copy of which may be requested from VicRoads. The road discontinuance is required for the purposes of the **Alpine Resorts and National Parks Acts Amendment Act 2013**.

SCHEDULE B**ARTERIAL ROAD**

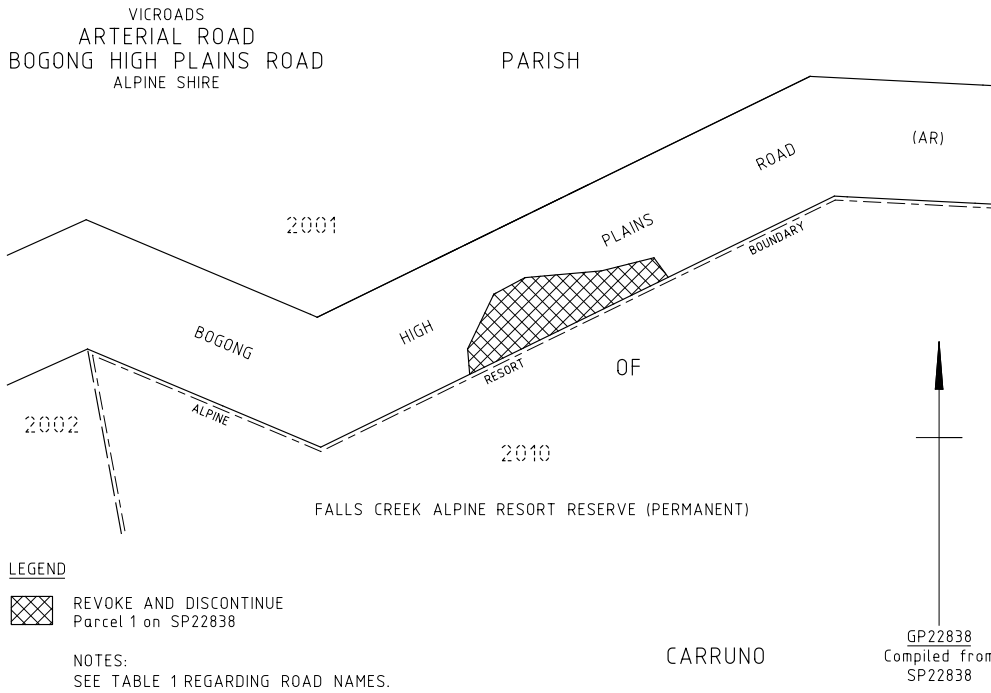
- a) That part of Bogong High Plains Road identified by hatching on the plan numbered GP22838 is discontinued as described in the legend in the said plan.
