## Domestic Animals Act 1994

NOTICE OF PROPOSAL TO MAKE THE CODE OF PRACTICE FOR THE OPERATION OF BREEDING AND REARING BUSINESSES (REVISION NUMBER 1)

I, Peter Walsh, Minister for Agriculture and Food Security, give notice of the proposal to make the Code of Practice for the Operation of Breeding and Rearing Businesses (Revision Number 1) and call for submissions for a period of 28 days under section 60 of the **Domestic Animals Act 1994**.

The Code of Practice for the Operation of Breeding and Rearing Establishments has been reviewed. This Code is made under the **Domestic Animals Act 1994** and must be complied with by owners, operators and staff of businesses that are required to be registered as breeding or rearing Domestic Animal Businesses under the Act. The primary objective of this review is to provide minimum standards for the accommodation, management and care appropriate to the needs of dogs and cats housed in breeding and rearing establishments.

Submissions are invited on the proposed Code of Practice for the Operation of Breeding and Rearing Businesses (Revision Number 1) to be made under section 59 of the **Domestic Animals Act 1994**.
