




#### ROAD EXCHANGE (DEVIATION) IN TOWNSHIP OF SWAN HILL


Version 4 of Council's RMP was adopted at the ordinary meeting of council on 25 June 2013 date.





Proposal to Make the General Purposes and Amenity Local Law

#### **Local Government Act 1989** – Section 119(2)

At its meeting on Wednesday 24 July the Council resolved to make the General Purposes and Amenity Local Law No. 10 2013.

#### Purpose of the General Purposes and Amenity Local Law

The proposed Local Law will replace the General Local Law No. 8 2003.

The purposes of the General Purposes and Amenity Local Law are to:

- (1) manage, regulate and control activities and uses on any land which:
  - (a) may be dangerous, cause a nuisance or be detrimental to the amenity of the area or the environment;
  - (b) are directed at maintaining a healthy and safe environment for residents and visitors:
  - (c) promotes an environment in which residents and visitors to the municipal district can enjoy a lifestyle that is expected of the area;
- (2) regulate and control behaviour which causes detriment to the amenity and environment of the municipality or could compromise public safety;
- (3) provide processes and requirements that complement Council Policies and Plans; and
- (4) provide for the administration of the Council's powers and functions.

#### General Purport of the Local Law

The proposed Local Law will achieve its purposes by a number of measures including:

- identifying uses and activities that will require a permit such as using a footpath for outdoor dining, placing moveable advertising signs on Council land or roads, using Council roads for works, planting on or landscaping naturestrips, locating a shipping container in residential zones for longer than 6 months, keeping excess numbers of animals and burning in the open air on land less than the prescribed size;
- identifying uses and activities which must comply with conditions or requirements in the Local Law including, in some instances, compliance with Council Policies or Plans, such as requirements applying to the

- operation and maintenance of septic tanks, vehicle crossings, limiting obstructions on roads, the use of scare guns, camping or using caravans or motorhomes, using motorised recreation vehicles and burning in the open air on land greater than the prescribed size;
- prohibited in certain circumstances such as allowing land or buildings to be kept in a way that is unsightly or detrimental to the general character and amenity of the neighbourhood or that could be a danger or a risk to people or property in the vicinity, behaving on Council land or on a road in a way that could harm or injure another person or which interferes with another person's reasonable enjoyment of that land or which could damage Council and community assets, and consumption of alcohol or the possession of alcohol in open containers on roads or Council land; and
- providing for the administration and enforcement of the Local Law through a permit system and creating offences for contravention of certain provisions in the Local Law.

Written submissions about the proposed Local Law will be considered in accordance with section 223 of the **Local Government Act 1989** and should be addressed to the Chief Executive Officer, Macedon Ranges Shire Council, PO Box 151, Kyneton 3444. Written submissions must be received at the Council Offices no later than 12.00 noon on Wednesday 4 September 2013.

Any person who makes a written submission can ask to be heard by the Council in support of their submission and may be represented by a person (who is specified in their submission), to act on their behalf. The date, time and place of any meeting to hear submissions on the Local Law will be directly notified to those who have asked to be heard.

Meeting Procedure Local Law (2013)

In accordance with section 119 of the Local Government Act 1989 (the 'Act'), notice is hereby given that the Melton City Council (the 'Council'), at its meeting of 23 July 2013, resolved to repeal Meeting Procedure Local Law No. 2 (2004), and replace it by making a new Local Law, Meeting Procedure Local Law (2013), under sections 91 and 111 of the Act.

- a) regulate proceedings and provide for orderly and fair conduct at all Council meetings, Special Committee meetings, Advisory Committee meetings, and other meetings conducted by or on behalf of Council where Council has resolved that provisions of this Local Law are to apply; and
- b) maintain open, efficient and effective processes of the government of the Council and assist with keeping the preparation of the agenda consistent from meeting to meeting; and
- c) regulate proceedings for the election of the Mayor and Chairperson of various committees; and
- d) regulate the use and prohibit unauthorised use of the common seal; and
- e) revoke Council's Meeting Procedure Local Law dated 20 December 2004.







Order in Council

The Governor in Council, under clause 12.2(b)(iii) of certain leases granted under the **Melbourne City Link Act 1995** in respect of certain unreserved Crown land situated beneath the elevated Southern Link structure east of Glenferrie Road and adjacent to Gardiners Creek, which leases are further described below, approves the purpose of the proposed sub-lease of part of the leased land. - (c) the following 'Trust Leases' (within the meaning of the Agreement):
  - (i) a lease dated 4 November 2002 in respect of Southern Link Section 1;
  - (ii) a lease dated 4 November 2002 in respect of Southern Link Section 5;
- (d) the 'Southern Link Upgrade Company Lease' and 'Southern Link Upgrade Trust Concurrent Lease' (within the meaning of the Agreement) to be granted pursuant to clause 4A.7(a) of the 'Concession Deed' entered into pursuant to the Agreement on substantially the same terms as the leases described in paragraphs (a), (b) and (c) above, and which, in accordance with clause 4A.8(g) of the Agreement, took effect on 30 November 2012.






