## NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

Parks Victoria, as the declared waterway manager for the waters of the Maribyrnong River upstream of Shepherd Bridge on Footscray Road, make the following notice under section 211(1)(b)(i) of the **Marine Safety Act 2010**.

For the purposes of works activity proposed by the Regional Rail Link for construction of a new rail pass on the Saltwater River Rail Bridge over the Maribyrnong River, the navigation and other movement of vessels in the works area is prohibited, excluding vessels involved in the works and Parks Victoria vessels.

Between 8.00 pm and 8.00 am each night the works area is 50 metres from the upstream drip-line of the Saltwater River Rail Bridge extending a total distance of 125 metres downstream covering the entire width of the Maribyrnong River, as marked by buoys.

Between 8.00 am and 8.00 pm each day the works area is 21 metres from the downstream drip-line of the Saltwater River Rail Bridge, to a distance of 21 metres from the upstream drip-line of the bridge covering the width of the western arch, as marked by buoys.

This notice has effect from Friday 2 August to Friday 9 August 2013. Dated 30 July 2013
