Determination of Hiring Rates

I, Terry Mulder, Minister for Public Transport, determine that the following fares shall apply in respect of the 'Geelong Share-Ride Taxi Service' pilot scheme coordinated by Geelong Taxi Network from the Safe City taxi rank at 95–113 Moorabool Street, Geelong. These fares may be charged in licensed vehicles authorised to operate as part of the pilot scheme by a temporary permit issued under section 154 of the **Transport (Compliance and Miscellaneous) Act 1983**.

The fare that a passenger may be charged for using the late-night share-ride taxi service is:

- \$8 (including GST and rank marshal levy) per passenger, per journey from the Safe City taxi rank to the passenger's nominated destination within Zone 1.
- \$17 (including GST and rank marshal levy) per passenger, per journey from the Safe City taxi rank to the passenger's nominated destination within Zone 2.

Zone 1 and Zone 2 are defined by suburb boundaries and areas as set out in the table below:
