## Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES ON CORRIGAN ROAD IN SPRINGVALE FOR THE WENTWORTH STUNT FILM SHOOT ON 28 JANUARY 2014

# 1 Purpose

The purpose of this Declaration is to exempt participants in the Wentworth Stunt Film Shoot from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on Corrigan Road, Springvale, commencing on 28 January 2014.

## 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a nonroad activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect at 8.00 pm on 28 January 2014.

# 4 Expiry

This notice expires at 4.00 am on 29 January 2014.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) 'Event' means the Wentworth Stunt Film Shoot, to be held on 28–29 January;
- b) 'Event Area' means the north-south segment of Corrigan Road, Springvale, between Racecourse Road and Racecourse Drive;
- c) 'Event Dates' means the period between 8.00 pm on 28 January 2014 and 4.00 am on 29 January 2014:
- d) 'Participants' means participants in the Event, including officers, members and authorised agents of Fremantle Media, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, George Mavroyeni, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
