## MAJOR SPORTING EVENT ORDER FOR AFC ASIAN CUP AUSTRALIA 2015

Order in Council

The Lieutenant-Governor, as the Governor's Deputy, with the advice of the Executive Council, under section 7 of the **Major Sporting Events Act 2009** (the Act), specifies each of the matters in Column 2 of Tables 1, 2 and 3 in accordance with the corresponding section of the Act in Column 1 of Tables 1, 2 and 3.
