### **Road Safety Act 1986**

#### DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES ON ROADS WITHIN THE SURFCOAST SHIRE FOR FILMING TO BE HELD ON WEDNESDAY 29 OCTOBER 2014

### 1 Purpose

The purpose of this Declaration is to exempt participants in the filming activities for the Subaru Television Commercial from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted within the SurfCoast Shire.

#### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect on Wednesday 29 October 2014 at 10.00 am once the road is declared closed by Victoria Police.

#### 4 Expiry

This notice expires on Wednesday 29 October 2014 at 8.00 pm.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires -

- a) 'Event' means filming activities for the Subaru Television Commercial, to be held on Wednesday 29 October 2014; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of Dynamite, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Charlie Broadhurst, as delegate of the Minister for Roads, under section 99B(4) of the **Road** Safety Act 1986 declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2.
