## ADVICE IN RELATION TO A NOTICE OF INTENTION TO REQUEST A WATERWAY RULE

I, Peter Corcoran, Director Maritime Safety (delegate of the Director, Transport Safety), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rules for the Local Port of Mallacoota, Bastion Point Boat Ramp, as submitted by Gippsland Ports Committee of Management Inc. on 13 October 2014 are of a material nature and that Gippsland Ports Committee of Management Inc. must comply with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rules under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requires Gippsland Ports Committee of Management Inc. to invite submissions and comments in relation to the proposed request from the public.
