#### Transport (Compliance and Miscellanous) Act 1983

DRIVER ACCREDITATION (METROPOLITAN HIRE CAR) AMENDING INSTRUMENT

- 1. I, James Holyman, Acting Chief Executive Officer of the Taxi Services Commission (TSC), acting under delegation from the TSC and in accordance with my powers under sections 166, 167 and 168 of the **Transport (Compliance and Miscellaneous)** Act 1983 (the Act), hereby amend the instrument entitled 'Driver Accreditation Application, Test, Course and Renewal Requirements' which was published in Special Edition No. S 212 of the Government Gazette on 27 June 2014 (Existing Instrument), as described in the Schedule to this instrument.
- 2. Unless otherwise indicated, all terms have the same meaning as in the Act.
- 3. Nothing in this instrument limits the discretion of the TSC under sections 166, 167 and 168 of the Act.
- 4. This instrument will come into effect on and from 8 December 2014.

#### SCHEDULE

#### 1. Test requirements: Applications for the issue of hire car driver accreditation

In Schedule 2 to the Existing Instrument, for the last line of Table 1, substitute:

Driver Accreditation Zone	Required Knowledge Test Components
Column 1	Column 2
Hire Car driver accreditation: Metropolitan Hire Car Zone	(a) Metropolitan Hire Car module

#### 2. Renewal of hire car driver accreditation

In Schedule 3 to the Existing Instrument, for the last line of the table following Item 2, **substitute**:

Applicant Category Column 1	Things required by the TSC Column 2
Metropolitan Hire Car Zone	1. Evidence that the applicant has successfully completed the following module of the Knowledge test, with a minimum score of 85 per cent, prior to the date of expiry of accreditation:
	(a) Metropolitan Hire Car module

#### 3. Definitions

In Schedule 4 to the Existing Instrument, amend the definition of 'Knowledge Test' as follows:

- (a) in subclause (iv), **delete** the word 'and'; and
- (b) following subclause (iv), insert:
  - '(v) Metropolitan Hire Car module; and'
