
## AMENDMENT OF ORDERS UNDER SECTION 98 OF THE ROAD SAFETY ACT 1986

I, John Merritt, Chief Executive of VicRoads and delegate of the Minister for Roads and Road Safety, by this Order made under section 98(1) of the **Road Safety Act 1986** ('Act'):

- 1. revoke the Order made under section 98 of the Act in relation to extending provisions to the park and ride facilities at certain railway station car parks published in Victoria Government Gazette No. G 48 dated 1 December 2011 in so far only as it refers to the Berwick Railway Station and the associated attached plan relating to the Berwick Railway Station;
- 2. extend the application of
  - a. sections 59, 64, 65, 65A, 76, 77, 84BA-84BI, 86–90 and 100 of the Act;
  - b. the Road Safety Road Rules 2009; and
  - Parts 8 and 9 of, and Schedules 6 and 7 to, the Road Safety (General) Regulations 2009 –

to the park and ride facilities located at Berwick Railway Station, particulars of which are shown hatched on the attached plan; and

3. amend the Orders made under section 98 of the Act in relation to extending provisions to the park and ride facilities at certain railway station car parks published in Victoria Government Gazette No. S 303 dated 3 September 2009, No. G 48 dated 1 December 2011 and No. G 31 dated 1 August 2013 to extend the application of sections 84BA-84BI of the Act to the park and ride facilities located at the stations referred to in those Orders and shown hatched on the plans attached to those Orders.
