Section 211(1)(b)

#### NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS.

Parks Victoria, as the declared waterway manager for the waters of the Yarra River upstream of the port waters of the Port of Melbourne under the **Marine Safety Act 2010**, makes the following notice under section 211(1)(b)(i) of the Act.

For the purposes of salvage works proposed by Elstone Diving Services Pty Ltd for the salvage and removal of the sunken vessel 'Spirit Of Melbourne' at Banana Alley Wharf on the Yarra River, under section 211(1)(b)(i), Parks Victoria provides the following notice that:

Prohibits the navigation and other movement of vessels in the works areas, excluding Parks Victoria vessels and other vessels involved in the works.

Between 6.00 am on 24 February 2014 to 5.00 pm on 7 March 2014, the works area is from the upstream drip-line of the northern arch of Sandridge Pedestrian Bridge, extending a distance of 80 m downstream to the mid-section of Banana Alley Wharf, as marked by water communication buoys.

On completion of removal the vessel will be towed by barge to the southern bank of the Yarra River 60 m downstream of Church Street Bridge, to South Yarra, known as Prahran Main Drain, to be disposed of by road transport. The work site will be marked by water communication buoys.

This notice has effect from Monday 24 February to Friday 7 March 2014.
