ROAD DECLARATION

VicRoads, pursuant to section 14 of the **Road Management Act 2004**, upon publication of this notice declares the road described in the Schedule and on the plan attached. The effect of this declaration on road names is described in Table 1.

VicRoads, upon publication of this notice, pursuant to section 37(1)(d)(i) of the **Road Management Act 2004**, declares that VicRoads is the responsible road authority for the road described in the Schedule and on the plan attached. VicRoads is also the coordinating road authority for the road in accordance with section 36(b) of the **Road Management Act 2004**.


EFFECTS ON ROAD NAMES
