ROAD DECLARATIONS AND DISCONTINUATIONS

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes, declares or renames the roads or parts of the roads described in Schedule A and on the plans attached.

ROAD DISCONTINUATIONS

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues parts of the roads described in Schedule B and on the plans attached and approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads under section 31 of the latter said Act.

The effects of these Road Declarations and Road Discontinuations on road names are described in Table 1.

SCHEDULE A

ARTERIAL ROAD

- a) That part of Heatherton Road identified by hatching on the plan numbered GP21995B is declared as described in the legend in the said plan.
- b) Those parts of Civic Drive identified by hatching on the plan numbered GP22384 are revoked as described in the legend in the said plan.
- c) That part of McDonalds Road identified by hatching on the plan numbered GP22384 is revoked as described in the legend in the said plan.
- d) Those parts of Settlement Road identified by hatching on the plan numbered GP22500 are revoked as described in the legend in the said plan.
- e) Those parts of Boundary Road identified by hatching on the plans numbered GP23066 and GP23067 are declared or renamed as described in the legend in the said plans.
- f) Those parts of Keilor-Derrimut Road identified by hatching or heavy solid line on the plans numbered GP23068 and GP309AR are declared or renamed as described in the legend in the said plans.
- g) That part of Fitzgerald Road identified by heavy dashed line on the plan numbered GP309AR is renamed as described in the legend in the said plan.
- h) Those parts of Truganina–Seabrook Road identified by hatching on the plan numbered GP23069 are declared as described in the legend in the said plan.

SCHEDULE B

ARTERIAL ROAD

- a) Those parts of Civic Drive identified by hatching on the plan numbered GP22384 are discontinued as described in the legend in the said plan.
- b) That part of McDonalds Road identified by hatching on the plan numbered GP22384 is discontinued as described in the legend in the said plan.
- c) Those parts of Settlement Road identified by hatching on the plan numbered GP22500 are discontinued as described in the legend in the said plan.

MUNICIPAL ROAD

- d) That part of Civic Drive identified by hatching on the plan numbered GP22384A is discontinued as described in the legend in the said plan.
- e) That part of Road identified by hatching on the plan numbered GP22385 is discontinued as described in the legend in the said plan.
- f) Those parts of Heyington Avenue identified by hatching on the plan numbered GP22501 are discontinued as described in the legend in the said plan.
- g) Those parts of Station Street identified by hatching on the plans numbered GP22502 and GP22506 are discontinued as described in the legend in the said plans.

EFFECTS ON ROAD NAMES


- 1. Names in Column 2 are existing Vicmap Address names, which are unaffected by this notice.

- 3. Names in Column 2 may not apply to the whole length of the road and are for general information only.


