NOTICE OF ACTIVITY EXCLUSION ZONE

I, Peter Corcoran, Director Maritime Safety (as delegate of the Director, Transport Safety) and I, Jo Richards, Acting District Manager, Port Phillip Western Port, as delegate of Parks Victoria the waterway manager for the Local Port of Port Phillip and the waters of Western Port Bay, hereby give notice under section 208(1) of the **Marine Safety Act 2010** (Vic) that persons and vessels not associated with 2014 Life Saving Victoria IRB Carnivals are prohibited from entering and remaining in the waters marked on land by signs and flags and extending approximately 350 metres off shore adjacent to the Life Saving Clubs detailed in Table 1.

The exclusion zones have effect for the dates, times, locations and events specified in Table 1 below.
