	(2)	If a provision of this Act does not come into operation before 1 July 2014, it comes into operation on that day.		
25/2014	(1)	This Act, except Part 2, comes into operation on the day after the day on which it receives the Royal Assent.		
	(2)	Subject to subsection (3), Part 2 comes into operation on a day or days to be proclaimed.		
	(3)	If a provision of Part 2 does not come into operation before 31 October 2014, it comes into operation on that day.		
26/2014	(1)	This Act (other than subsections (2) and (3)) comes into operation on 1 July 2014.		
	(2)	Section 456 comes into operation on the later of –		
		(a) 1 July 2014; and		
		(b) the day on which section 278 of the Victoria Police Act 2013 comes into operation.		
	(3)	Section 457 comes into operation on the later of –		
		(a) 1 July 2014; and		
		(b) the day on which section 158 of the Legal Profession Uniform Law Application Act 2014 comes into operation.		
27/2014	(1)	This Act comes into operation on a day or days to be proclaimed.		
28/2014	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.		
	(2)	If a provision of this Act does not come into operation before 1 July 2014, it comes into operation on that day.
