- 31/2014 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 September 2014, it comes into operation on that day.
- 32/2014 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 September 2014, it comes into operation on that day.
- 33/2014 (1) This Part and Part 3 (other than section 7) come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 July 2015, it comes into operation on that day.
- 34/2014 (1) This Act (except Part 3) comes into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Part 3 comes into operation on 1 July 2014.
- 35/2014 (1) This Part, sections 45 and 46, Part 3 and Divisions 1 and 3 of Part 5 come into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 March 2015, it comes into operation on that day.
