NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

Parks Victoria, as the declared waterway manager for the waters of the Maribyrnong River upstream of Shepherd Bridge on Footscray Road, hereby cancels the gazette notice S128 published 16 April 2014 in relation to the works on Shepherd Bridge on the Maribyrnong River, and makes the following notice under section 211(1)(b)(i) of the **Marine Safety Act 2010** (Vic.).

For the purposes of the works activity proposed by McElligotts Pty Ltd for the scaffolding and re-painting works on Shepherd Bridge over the Maribyrnong River, the navigation and other movement of vessels in the works area is prohibited, excluding vessels involved in the works and Parks Victoria vessels.

Works area:

- Western Arch: Between 6.00 am 5 May 2014 to 6.00 pm 20 May 2014, the works area is from the upstream drip-line of Shepherd Bridge, extending a distance of 25 metres upstream and downstream covering the Western Arch, as marked by water communication buoys.
- Eastern Arch: Between 6.00 am 21 May 2014 to 6.00 pm 4 June 2014 the works area is from the upstream drip-line of Shepherd Bridge, extending a distance of 25 metres upstream and downstream covering the Eastern Arch, as marked by water communication buoys.
- Centre Arch: Between 6.00 am 5 June 2014 to 6.00 pm 24 June 2014 the works area is from the upstream drip-line of Shepherd Bridge, extending a distance of 25 metres upstream and downstream covering the Centre Arch, as marked by water communication buoys.

Scaffolding will remain in place from 5 May 2014 to 30 September 2014, for the duration of works with a reduced bridge height of 4.5 metres from the underside soffit of the bridge at high water.

This notice has effect from Wednesday 5 May to 30 September 2014.
