## Road Management Act 2004

In accordance with section 54 of the **Road Management Act 2004** (the 'Act'), the East Gippsland Shire Council gives notice that it intends to conduct a review of its Road Management Plan ('RMP').

The purpose and general purport of the review, consistent with the role, function and responsibilities of the Council as a road authority under the Act, is to revise maintenance responsibility for assets situated on private property, amend road register update intervals, update references and make miscellaneous corrections where required to ensure that the standards and priorities to be given to the inspection, maintenance and repair of the roads to which Council's RMP applies are safe, efficient and appropriate for use by the community.

The review will apply to all roads and footpaths/walking tracks and classes of roads and footpaths/walking tracks to which the RMP applies.

The current RMP with proposed changes will be available for inspection at Council's Corporate Centre in Bairnsdale, Council's Service Centres at Lakes Entrance, Paynesville, Orbost and Omeo, or at Council's Outreach Centres at Buchan, Cann River and Bendoc, or accessed online at [www.eastgippsland.vic.gov.au](http://www.eastgippsland.vic.gov.au)

Pursuant to regulation 303 of the Road Management (General) Regulations 2005, any person aggrieved by the proposed review of the RMP may make a written submission by 16 July 2014 and should be addressed 'Review of Road Management Plan' and addressed to the Chief Executive Officer, East Gippsland Shire Council, PO Box 1618, Bairnsdale, Victoria 3875.

Any person who has made a submission and requested that they be heard in support of their submission is entitled to appear in person or by a person acting on their behalf before a meeting of a committee of Council, the day, time and place which will be advised.
