#### 40/2014

(L.S.)

- (1) This Act (except Part 2, section 18, Division 4 of Part 4 and Parts 6 and 7) comes into operation on the day after the day on which it receives the Royal Assent.
- (2) Section 18 is taken to have come into operation on 12 December 2007.
- (3) Parts 2 and 7 come into operation on 1 July 2014.
- (4) Part 6 comes into operation on 1 July 2015.
- (5) Subject to subsection (6), Division 4 of Part 4 comes into operation on a day to be proclaimed.
- (6) If Division 4 of Part 4 does not come into operation before 1 December 2014, it comes into operation on that day.

#### 41/2014

(1) This Part and Parts 4 and 5 come into operation on the day after the day on which it receives the Royal Assent.

# SPECIAL

- (2) Sections 13 and 14 are to be taken to have come into operation on 3 December 2013.
- (3) Subject to subsection (4), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (4) If a provision referred to in subsection (3) does not come into operation before 1 July 2015, it comes into operation on that day.

# 42/2014

- (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 31 October 2014, it comes into operation on that day.

### 43/2014

- (1) Subject to subsection (3), this Act, other than section 37, comes into operation on a day or days to be proclaimed.
- (2) Section 37 comes into operation on the later of—
  - (a) the day on which section 5 comes into operation; and
  - (b) the day on which section 278 of the **Victoria Police Act 2013** comes into operation.
- (3) If a provision of this Act, other than section 37, does not come into operation before 1 December 2014 it comes into operation on that day.
