





#### Road Discontinuance

Pursuant to section 206 and Schedule 10, Clause 3 of the Local Government Act 1989, the Moonee Valley City Council at its meeting on 24 June 2014, formed the opinion that the section of road abutting 1-3 Grice Crescent and 972-978 Mt Alexander Road, Essendon, shown hatched on the plan below, is not reasonably required as a road for public use and resolved to discontinue the road and sell the land to the abutting owners.

The section of road shown hatched is to be discontinued subject to the right, power or interest held by City West Water in the road in connection with any sewers, drains or pipes under the control of that authority in or near the road.

Notice is hereby given that Mitchell Shire Council intends to make a local law (the proposed Local Law), to be known as the Meeting Procedure Local Law 2014, in accordance with sections 111 and 119 of the Local Government Act 1989 (the Act).

#### Purpose and general purport of Local Law

The purpose of the proposed Local Law is to provide for the election of the Mayor; regulate the use of the common seal; prohibit the use of the common seal or any device resembling the common seal; provide for the procedures governing the conduct of Council meetings and Special and Advisory Committee meetings; and set the rules of behaviour for those participating in or present at Council meetings and Special Committee and Advisory Committee meetings.

The proposed Local Law, in effect, amends the provisions of the current Meeting Procedure Local Law 2010. The general purport of the proposed Local Law is to update and improve Council's governance processes in relation to:

- election of the Mayor
- notice of meetings and cancellation of meetings
- business to be dealt with at meetings including general business, notices of motion, procedural motions and rescission motions;
- introduction of motions and amendments, voting procedures and minutes of meetings
- public participation at meetings including submissions, public questions and presentations
- rules of behaviour for those participating in or present at Council and Committee meetings
- application of relevant provisions of the Local Law to meetings of Special Committees and Advisory Committees

#### **Enquiries and submissions**

#### **EXEMPTION**

Application No. H100/2014

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Women's Health in the South East Inc. (the applicant). The application for exemption is to enable the applicant to:

- (a) employ only women in the organisation;
- (b) provide membership services to women only; and
- (c) advertise those matters (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavits of Susan Glasgow, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant is a not-for-profit, community-based women's health service run by women for women. It provides health information, health promotion and education to the female community and health professionals. The applicant assists women, particularly those who are significantly marginalised, to access the services they need. It also advocates for improved health services and encourages women to take more effective control of their health and wellbeing. The applicant is funded through the Department of Health's Women's Health Program.
- The applicant currently has two full-time employees and nine part-time employees. All staff are, from time to time, required to have direct telephone or face-to-face contact with women seeking services and advice. The applicant's experience is that the women clients prefer to speak with other women particularly as many matters are of a very personal nature. Having all women staff is consistent with the purposes for which the applicant was established.
- The applicant provides membership-related services, including meetings. Its preference is that representatives of organisations which attend meetings are women. To the extent that the membership and attendance at meetings involves the provision of services, an exemption is sought.
- No exception or current exemption already applies to the exempt conduct and in the absence of an exemption the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who would wish to be employed by the applicant or participate in or receive membership services. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 9 July 2019.

- 2. The interim exemption is granted in respect of the operation of sections 16, 18, 21, 105, 107 and 182 of the Act insofar as those sections relate to the 'race' (as that attribute is defined in section 4 of the Act) of employees, job applicants, and contract workers of the applicant companies.
- 3. The class of activities for which the exemption is granted is discrimination against employees, job applicants and contract workers, where such discrimination is required for the applicant companies to undertake certain defence projects (Controlled Projects) in compliance with the laws of the United States of America, in particular the International Traffic in Arms Regulations and the Export Administration Regulations (together U.S. Export Laws). The exemption granted would permit the applicant companies to:—
  - (a) In Controlled Projects only, require employees, job applicants and contract workers of the applicant companies to provide details of their nationality and place of birth to enable the applicant companies to determine whether those people are permitted by U.S. Export Laws to work on Controlled Projects and/or to access technology, materials or information that are subject to restriction under the US Export Laws (Controlled Material);
  - (b) Identify, via a list with limited distribution to only those officers and employees with a need to know, those employees and contract workers that are permitted to access Controlled Material or work on Controlled Projects based on US Export Laws restrictions;
  - (c) Identify by means of security levels on employee's or contract worker's access passes, which must be worn by all employees and contract workers of the applicant companies to access each site, the level of access permitted to that employee or contract worker to Controlled Material or Controlled Projects based on US Export Laws restrictions;
  - (d) Restrict access of employees and contract workers to Controlled Material or Controlled Projects based on US Export Laws restrictions;
  - (e) Reject applications from job applicants to join the applicant companies' workforce in positions requiring access to Controlled Material or relating to Controlled Projects based on US Export Laws restrictions;
  - (f) Transfer employees and contract workers from Controlled Projects regulated by the US Export Laws to non-Controlled Projects on the basis that the US Export Laws do not permit them to work on those Controlled Projects;
  - (g) Require employees and contract workers involved in Controlled Projects to notify the applicant companies of any change to their nationality;
  - (h) Provide to companies that transfer Controlled Material to the applicant companies, details of the nationality and place of birth of those employees and contract workers in the applicant companies' workforce who will have access to the Controlled Material;
  - (i) Provide to companies who use Controlled Material regulated by US Export Laws at their facilities, details of the nationality and place of birth of those in the applicant companies' workforce who will attend those facilities; and
  - (j) Enter into agreements with the applicant companies' employees, contract workers, contractors, agents and consultants pursuant to which those third parties undertake to comply with the matters referred to in (a) to (i) above.


