Order in Council

The Lieutenant-Governor of Victoria, as the Governor's Deputy, with the advice of the Executive Council under section 8(1)(a)(i) of the **Cemeteries and Crematoria Act 2003** appoints The Geelong Cemeteries Trust to manage the Colac Public Cemetery and the Queenscliff Public Cemetery.

The Lieutenant-Governor of Victoria, as the Governor's Deputy, with the advice of the Executive Council under section 8(1)(d) of the **Cemeteries and Crematoria Act 2003** abolishes The Colac Cemetery Trust and transfers all of the Trust's assets and liabilities (contingent and otherwise), duties and obligations in relation to staff, duties and obligations under contracts and other arrangements, records and registers to The Geelong Cemeteries Trust.

The Lieutenant-Governor of Victoria, as the Governor's Deputy, with the advice of the Executive Council under section 8(1)(d) of the **Cemeteries and Crematoria Act 2003** abolishes The Queenscliff Cemetery Trust and transfers all of the Trust's assets and liabilities (contingent and otherwise), duties and obligations in relation to staff, duties and obligations under contracts and other arrangements, records and registers to The Geelong Cemeteries Trust.

This Order comes into effect on the day of its making.
