





- control:
  - fires and promote fire prevention;
  - advertising and bill posting;
  - drainage;
  - noise:
- protect Council assets including footpaths, roads and reserves;
- provide for a permit to be required in respect to certain activities including to:
  - light an open fire;
  - camp in a public place;
  - use a caravan for the purposes of habitation;
  - store machinery or second hand goods;
  - place a trade waste skip on public land;
  - play amplified music in a Council reserve;
  - keep more than the prescribed number of animals or birds allowed;
  - place a clothing recycling bin on private land;
  - install or relocate a vehicle crossing;
  - place an obstruction on a road reserve;
  - tap into or interfere with a Council drain;
  - drive livestock on a road;
  - place signs, goods or furniture on a road or footpath;
  - carry out works on a road

- hold a street party, street party or procession;
- solicit, collect money or goods or sell raffle tickets in a public place; and
- trade on a road;
- set out penalties for first and subsequent offences against the local law;
- incorporate Council's Urban Nature Strip Guidelines which allow property owners to install alternative nature strip treatments subject to certain conditions designed to minimise risk to public safety and to protect Council assets;
- incorporate Council's Clothing Recycling Bin Policy and Guidelines to control the placement and management of recycling clothing bins on private land;
- incorporate Council's Waste Management Code to regulate the use and placement of garbage and recycling bins on roads and regulate kerbside hard waste and bundled branch collections;

#### **EXEMPTION**

#### Application No. H136/2014

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Bell Post Hill Bowls Club (the applicant). The application for exemption is to enable the applicant to organise and operate two women-only lawn bowls tournaments and advertise those matters (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavits of Suzanne Standaert, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- A copy of the application was sent by the Tribunal to the Victorian Equal Opportunity and Human Rights Commission (the Commission). The Commission did not seek leave to intervene in the proceeding.
- The two women-only tournaments have been held for 22 years. One is held in November and one in January each year. The women-only tournaments allow women of all ages and abilities to participate in a nonthreatening environment. In particular, the tournaments are attended by older women members of the applicant club who do not play pennant.
- There is a similar men-only tournament held at the applicant club each February.
   The arrangements at the applicant club for bowls allow for a number of mixed events including an annual mixed fours tournament.
   The applicant has received no complaints about the women-only tournaments.
- I am not satisfied that one of the exceptions contained in the Act applies to the conduct and there is no current exemption which applies to the exempt conduct. In the absence of an exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who would wish to play in the tournaments. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 13 August 2019.




