59/2014	(1)	This Act (except section 28) comes into operation on the day after the day on which it receives the Royal Assent.		
	(2)	Subject to subsection (3), section 28 comes into operation on a day to be proclaimed.		
	(3)	If section 28 does not come into operation before 1 August 2015, it comes into operation on that day.		
60/2014	(1)	Subject to this section, this Act comes into operation on a day or days to be proclaimed.		
	(2)	Division 1 of Part 9 comes into operation on the later of –		
		(a) the day after the day on which this Act receives the Royal Assent; and		
		(b) the day on which section 278 of the Victoria Police Act 2013 comes into operation.		
	(3)	Division 2 of Part 9 comes into operation on the later of –		
		(a) the day after the day on which this Act receives the Royal Assent; and		
		(b) the day on which section 157 of the Legal Profession Uniform Law Application Act 2014 comes into operation.
