		(a) the day on which section 3 comes into operation; and		
		(b) the day on which section 158 of the Legal Profession Uniform Law Application Act 2014 comes into operation.		
	(3)	If a provision of this Act, other than section 148, does not come into operation before 1 August 2015, it comes into operation on that day.		
68/2014	(1)	Subject to subsection (3), this Act (except section 64) comes into operation on a day or days to be proclaimed.		
	(2)	Section 64 comes into operation on the later of –		
		(a) the day on which section 44 comes into operation; and		
		(b) the day on which section 879 of the Water Act 2014 comes into operation.		
	(3)	If a provision of this Act (except section 3, 6, 13, 25, 63, 64 or 69) does not come into operation before 1 September 2015, it comes into operation on that day.		
69/2014	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.		
	(2)	If a provision referred to in subsection (1) does not come into operation before 1 July 2015, it comes into operation on that day.		
70/2014	(1)	1) This Act comes into operation on the day after the day on which it receives the
