


#### ROAD DISCONTINUANCE





#### DISCONTINUANCE OF CROWN ROAD

Under section 206(1), Schedule 10, Clause 3 of the **Local Government Act 1989** (Act), Golden Plains Shire Council, at its Ordinary meeting held on 16 December 2014, formed the opinion that the Crown road shown on the plan below (road) was not reasonably required for public use and that the land in the discontinued road was reasonably required to be transferred to the Crown for Crown land purposes and, with the consent of the Crown, resolved to discontinue the road and to transfer the land from the discontinued road to the Crown.

The discontinuance of the road does not affect any right, power or interest held by any public authority in the road in connection with any sewers, drains, pipes, wires or cables under the control of the authority in or near the road as saved by section 207C of the Act.




