Notice of Approval of Amendment Amendment C266

The Minister for Planning has approved Amendment C266 to the Melbourne Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment changes the word 'schedule' to the word 'scheme' in the transitional provisions of the Capital City Zone (Schedules 1, 2 and 3) and the Design and Development Overlay (Schedules 2, 7, 40, 60 and 62), to ensure that applications lodged prior to the gazettal of Amendment C262 are assessed against the version of the scheme in operation at that time. In addition, minor grammatical and spelling errors have been rectified.

Notice of Approval of Amendment

Amendment C141

The Minister for Planning has approved Amendment C141 to the Glen Eira Planning Scheme.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment inserts a new incorporated document titled 'Level Crossing Removal Project – Centre Road, Bentleigh and McKinnon Road, McKinnon Incorporated Document, September 2015' (the incorporated document) into the schedules to Clause 52.03 and Clause 81.01 of the Glen Eira Planning Scheme to allow land identified in the incorporated document to be used and developed for a level crossing removal project, without a permit, subject to conditions in the incorporated document.
