Notice of Approval of Amendment

Amendment C283

The Minister for Planning has approved Amendment C283 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment extends interim heritage controls applying to 85–105 Sutton Street, North Melbourne (HO1118), until 31 May 2016 and corrects a technical error in the wording of Clause 4.0 to Design and Development Overlay Schedule 10.

Notice of Approval of Amendment Amendment C208

The Minister for Planning has approved Amendment C208 to the Yarra Planning Scheme.

The Amendment modifies the Schedule to Clause 43.01 – Heritage Overlay to extend interim heritage controls on 326 Highett Street, Richmond; 3 Cotter Street, Richmond; 84 York Street, Richmond; 6 Egan Street, Richmond; and 77–79 Burnley Street, Richmond, until 31 May 2016.
