Road Safety Act 1986 ROAD SAFETY (VEHICLES) REGULATIONS 2009 Declared Apprenticeships

1. Purpose

The purpose of this notice is to declare certain approved training schemes to be declared apprenticeships for the purposes of determining eligibility for a 50% discount on the fee to be paid for registration or renewal of registration of a vehicle that needs to be used in the course of employment under a declared apprenticeship.

2. Authorising provision

This notice is made under regulation 6(1) of the Road Safety (Vehicles) Regulations 2009 (in this notice to be referred to as the Vehicles Regulations).

Regulation 6(1) of the Vehicles Regulations provides that the Roads Corporation may declare an approved training scheme to be a declared apprenticeship for the purposes of these Regulations. Under item 19 of Schedule 3 to the Vehicles Regulations, a person who is employed under a declared apprenticeship (and who meets the other criteria prescribed) may be eligible for a discount of 50% on the base fee on registration of their vehicle.

3. Commencement

This notice comes into operation on 16 November 2015 and applies to an application for vehicle registration made on or after 1 January 2016 and an application for renewal of vehicle registration that expires on or after 1 January 2016.

4. Expiry

This notice expires five years from the date of publication, unless revoked earlier.

5. Declaration

I, John Merritt, Chief Executive of the Roads Corporation, do hereby declare that, for the purposes of regulation 6(1) of the Vehicles Regulations, an approved training scheme is a declared apprenticeship if it is contained in the list of approved training schemes featured below:

The list of approved training schemes is provided and maintained by the Victorian Registration and Qualifications Authority (VRQA). It reflects the Victorian Government decision to provide the 50% vehicle registration discount to apprentice bricklayers, carpenters, joiners, electricians and plumbers.

1. Words and phrases in this notice (apart from the table) have the same meanings as in the **Road Safety Act 1986** and the Vehicles Regulations.
2. The VRQA will publish the list of approved training schemes on the VRQA website, <http://www.vrqa.vic.gov.au>. It can also be obtained by telephoning the VRQA on 1300 722 603.
3. The VRQA advises that new versions of approved training schemes supersede older versions at least once every few years. Therefore, the list of approved training schemes will be subject to minor changes as new versions are approved and declared. The list will be kept current on the VRQA website.
