#### Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES ON ROADS WITHIN SURCOAST SHIRE, COLAC OTWAY SHIRE AND CORANGAMITE SHIRE FOR FILMING TO BE HELD ON MONDAY 21 DECEMBER 2015 AND TUESDAY 22 DECEMBER 2015

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the filming activities for Itchy & Scratch Pictures from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on Roads within SurfCoast Shire Colac Otway Shire and Corangamite Shire.

#### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect on Monday 21 December 2015 starting at 5.00 am once Victoria Police have declared the road closed for filming.

#### 4 Expiry

This notice expires on Tuesday 22 December 2015 at 7.00 pm.

#### 5 Definitions

In this notice, unless the context or subject matter otherwise requires –

- 'Event' means filming activities for Itchy and Scratch Pictures, to be held on Monday
   21 December 2015 and Tuesday 22 December 2015; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of Itchy & Scratch Pictures, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Michael McCarthy, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2.
