Electricity Industry Act 2000

MINISTERIAL ORDER UNDER SECTION 35(3B)

I, Lily D'Ambrosio, Minister for Energy and Resources and Minister responsible for administering the **Electricity Industry Act 2000** (the Act), specify pursuant to section 35(3B)(a) of the Act, the following dates on which a licensee may publish a notice under section 35(3) of the Act.

1. Commencement

This Order commences on the date that section 7 of the **Energy Legislation Amendment (Consumer Protection) Act 2015** comes into operation.

2. Dates on which a notice varying licensee standing offers must be published

If a licensee proposes to publish a notice under section 35(3) of the Act, varying the tariffs determined by the licensee and published in the Government Gazette under section 35(1) of the Act, a notice may be published on the following dates:

- (a) 27 January 2016;
- (b) 3 June 2016.

Gas Industry Act 2001

MINISTERIAL ORDER UNDER SECTION 42(3B)

I, Lily D'Ambrosio, Minister for Energy and Resources and Minister responsible for administering the **Gas Industry Act 2001** (the Act), specify pursuant to section 42(3B)(a) of the Act, the following dates on which a licensee may publish a notice under section 42(3) of the Act.

1. Commencement

This Order commences on the date that section 22 of the **Energy Legislation Amendment (Consumer Protection) Act 2015** comes into operation.

2. Dates on which a notice varying licensee standing offers must be published

If a licensee proposes to publish a notice under section 42(3) of the Act, varying the tariffs determined by the licensee and published in the Government Gazette under section 42(1) of the Act, a notice may be published on the following dates:

- (a) 27 January 2016;
- (b) 3 June 2016.
