The cooperation of the public is sought to establish the identity of the driver of a motor vehicle that failed to stop and render assistance to Luke Ryan Shaw who suffered fatal injuries as a result of a motor vehicle incident in Ninth Street, Mildura, on 21 October 2005.








## GREATER GEELONG CITY COUNCIL

Once discontinued, the road will be sold to the common owner of 18 and 20 Fitzroy Street, Geelong 3220.




## MONASH CITY COUNCIL

#### NOTICE UNDER DOMESTIC ANIMALS ACT 1994

On the 18 November 2015, the Bass Coast Shire Council (Council) made an Order under section 26(2) of the **Domestic Animals Act 1994** (Act) in relation to the control of dogs in areas within Bass Coast Shire that from 1 January 2016 the following areas are Designated Dog Off-Leash Areas:

- Corinella beach 90 metres south of the Beach Street access, south-east to O'Connor Road ending before the access to the beach;
- Coronet Bay beach 80 metres south of Norsemens Road entrance towards Coronet Bay township, ending in line with the end of Kowloon Crescent;
- Grantville beach 30 metres south of the Swan Street beach access south towards the boat ramp and ending at the Grantville Hall beach access track;





It is a condition of this exemption that:

- (a) the person must not be a prohibited person under the **Control of Weapons Act 1990**;
- (b) the authorised and approved police custody officer training or educational exercises must be under the control and supervision of appropriately qualified and authorised members of Victoria Police personnel; and
- (c) the person must not be subject to any limitation applied to their authorisation to act as police custody officer by the Chief Commissioner of Police under section 200E of the Victoria Police Act 2013 that would prevent them from bringing into Victoria, causing to be brought into or sent into Victoria, possessing, carrying or using an item listed in Column 2 of the Table above.
