ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares the roads described in the Schedule and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE

ARTERIAL ROAD

- a) Those parts of Wellington Road identified by hatching on the plan numbered GP21344 are declared as described in the legend in the said plan.
- b) Those parts of Hyland Highway identified by hatching on the plan numbered GP22864 are declared as described in the legend in the said plan.
- c) That part of Berwick–Cranbourne Road identified by hatching on the plan numbered GP22373B is declared as described in the legend in the said plan.
- d) Those parts of Main Whittlesea Road identified by hatching on the plan numbered GP22395 are declared as described in the legend in the said plan.
- e) Those parts of Western Highway identified by hatching and cross-hatching on the plan numbered GP22780 are declared as described in the legend in the said plan.
- f) Those parts of Carrum Downs–Seaford Road identified by hatching on the plans numbered GP22118A, GP22119 and GP22120 are declared as described in the legend in the said plans.
- g) Those parts of Dandenong Valley Highway identified by hatching on the plan numbered GP22120 are declared as described in the legend in the said plan.
- h) Those parts of Yan Yean Road identified by hatching and cross-hatching on the plans numbered GP23364, GP23364A, GP23364B, GP23364C and GP23364D are declared as described in the legend in the said plans.
- i) Those parts of Kurrak Road identified by hatching on the plan numbered GP23364 are declared as described in the legend in the said plan.
- j) Those parts of Bridge Inn Road identified by hatching on the plans numbered GP23364D, GP23364E and GP23364F are declared as described in the legend in the said plans.
- k) That part of Main Whittlesea Road identified by hatching on the plan numbered GP23364F is declared as described in the legend in the said plan.

- l) That part of Berwick Road identified by hatching on the plan numbered GP21344A is declared as described in the legend in the said plan.
- m) That part of Colemans Road identified by hatching on the plan numbered GP22119A is declared as described in the legend in the said plan.
- n) Those parts of Enterprise Avenue identified by hatching on the plan numbered GP22373C are declared as described in the legend in the said plan.
