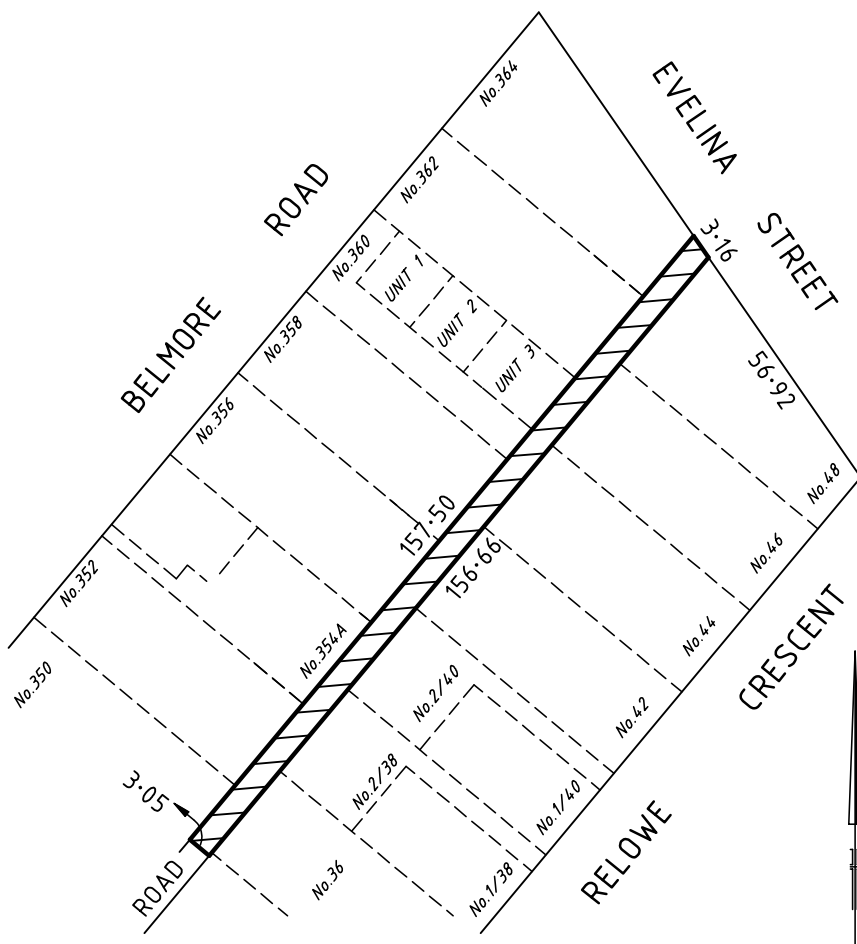

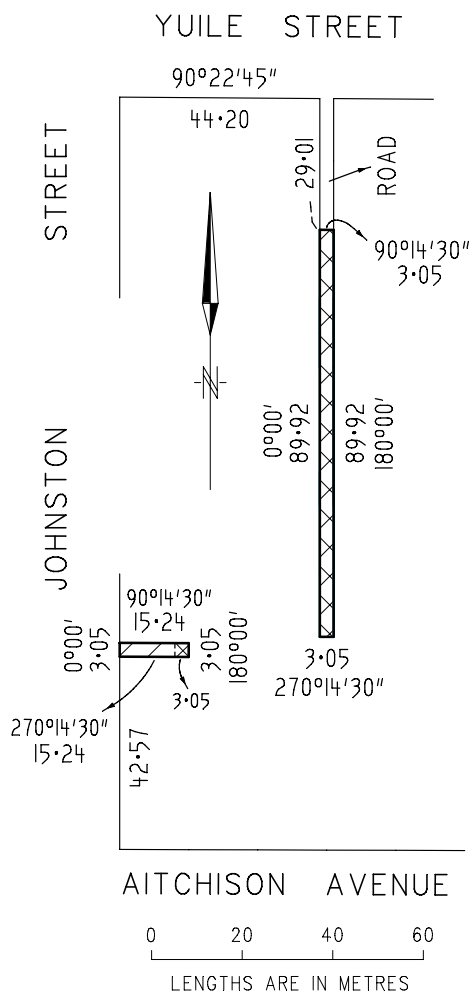

PART OF CROWN PORTION 141



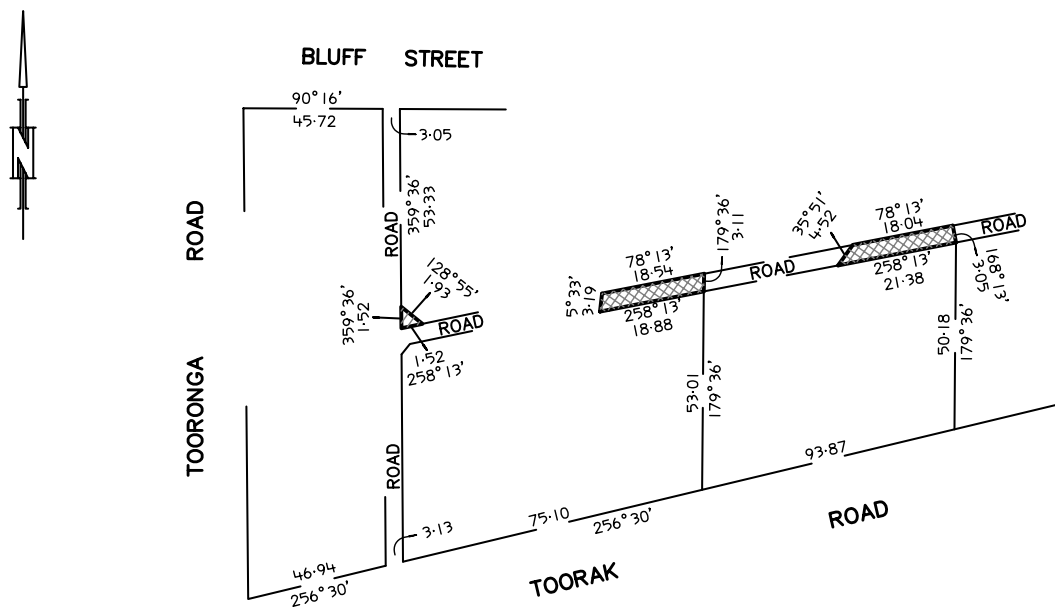

Notice of Preparation of Amendment
Amendment C161

The Greater Bendigo City Council has prepared Amendment C161 to the Greater Bendigo Planning Scheme.

The Amendment proposes to change the planning controls for approximately 313 hectares of land in Marong to facilitate the proposed Marong Business Park. The proposal also includes the establishment of a buffer and a new drainage corridor on land adjoining the proposed business park, and the protection of heritage buildings.

The land affected by the Amendment is:

- 20 Yorkshire Road, Wilsons Hill (Lot 1 TP215794W);

INTERIM EXEMPTION

Application No. H5/2015

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Torquay Bowls Club Inc. (the applicant). The application for exemption is to enable the applicant to organise and operate each year two women-only and two men-only lawn bowls tournaments and advertise those matters (the exempt conduct).

Upon reading the material filed in support of this application, including having heard from a representative of the applicant at a directions hearing on 16 February 2015, the Tribunal is satisfied that it is appropriate to grant an interim exemption from sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct until the application is finally heard and determined.

In granting this exemption, the Tribunal noted:

- The applicant wishes to conduct two women-only bowls tournaments on 22 February 2015 (Torquay Bowls Club Open Day) and 2 April 2015 (Invitation Fours) and for those tournaments to be held each year. The tournaments are intended to increase the participation of women at the applicant club, including participating in mixed pennant bowls competitions. In addition, the applicant wishes to hold similar men-only tournaments during the year. The dates of those tournaments are not known at this stage.
- I am not satisfied that one of the exceptions contained in the Act applies to the conduct and there is no current exemption which applies to the exempt conduct. In the absence of an exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of women or men who wish to participate in the two tournaments restricted to the other gender. I am satisfied that for the purposes of this interim exemption, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an interim exemption from the operation of sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 15 June 2015.

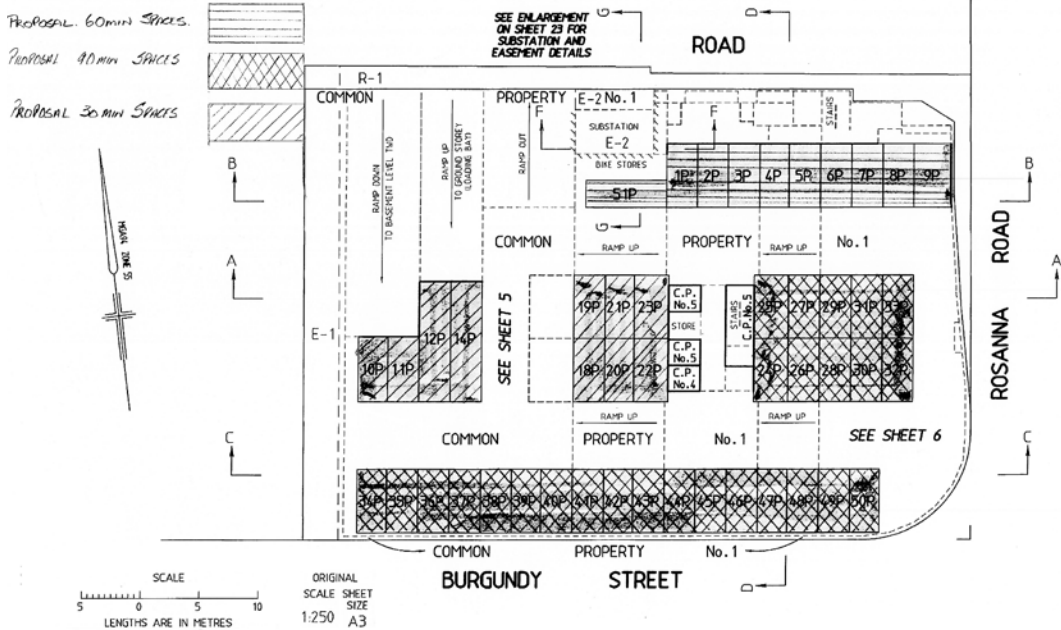
