#### Plant Biosecurity Act 2010

## ORDER DECLARING RESTRICTED AREAS FOR THE CONTROL OF GIANT PINE SCALE

I, Jaala Pulford, Minister for Agriculture, under section 32 of the **Plant Biosecurity Act 2010** make the following Order declaring restricted areas for the control of giant pine scale and specifying the prohibitions, restrictions and requirements which are to operate in the restricted areas. Dated 3 February 2015

#### 1 Objective

The objective of this Order is to declare restricted areas for the control of giant pine scale in Victoria, and to specify the prohibitions, restrictions and requirements which are to operate in the restricted areas.

#### Authorising Provision

This Order is made under section 32 of the Plant Biosecurity Act 2010 (the Act).

#### 3 Definitions

In this Order –

'giant pine scale' means the exotic pest Marchalina hellenica (Gennadius);

'giant pine scale host material' means any giant pine host plant and any earth material or used equipment associated with any giant pine scale host plant;

'giant pine scale host plant' means any plant listed in Schedule 1 and excluding plants in tissue culture;

'inspector' means a person authorised as an inspector under the Act.

#### 4 Restricted area for the Control of Giant Pine Scale

The Restricted Areas for the control of giant pine scale are declared to be the areas described in Schedule 2.

#### 5 Prohibitions, Restrictions and Requirements

- (1) The removal of any giant pine scale host material from the restricted areas is prohibited.
- (2) Subclause (1) does not apply if the person removing any giant pine scale host material is authorised to do so under a permit issued by an inspector under the Act and complies with any conditions set out in the permit.
- (3) All giant pine scale host material must be destroyed, pruned or treated in a manner approved by the Chief Plant Health Officer of the Department of Economic Development, where necessary to control or prevent the spread of the exotic pest.
- (4) The planting or propagation of any giant pine scale host plant is prohibited.

#### 6 Issuing of Directions

Inspectors are authorised to issue a direction to any owner or occupier of land in the restricted areas -

(1) requiring the owner or occupier to –

- (a) take measures to destroy or prune any giant pine scale host plant where this is considered necessary to control or prevent the spread of the exotic pest; or
- (b) apply, to any giant pine scale host plant, any treatment for the purpose of controlling giant pine scale, including the application of chemicals registered, approved or permitted for the purpose of controlling giant pine scale, or
- (c) clean used equipment utilised in the destruction, pruning or mulching of giant pine scale host plants.

Note:

Section 17(2) of the **Plant Biosecurity Act 2010** provides that a person must notify an inspector without delay after becoming aware or suspecting that an exotic pest is present by the fastest means of communication available.

Section 33 of the **Plant Biosecurity Act 2010** provides that a person is guilty of an offence and liable for a penalty not exceeding 60 penalty units in the case of a natural person, and 300 penalty points in the case of a body corporate for causing or permitting the movement of any host material from a restricted area contrary to any restrictions, unless authorised to do so by a permit issued by an Inspector.

Section 35(4) of the **Plant Biosecurity Act 2010** provides that a person is guilty of an offence and liable for a penalty not exceeding 50 penalty points for contravening any direction of an Inspector.
